<li>using passive verbs to affect the presentation of information in a sentence</li> <li>using the perfect form of verbs to mark relationships of time and cause</li> <li>using expanded noun phrases to convey complicated information concisely</li> <li>using modal verbs or adverbs to indicate degrees of possibility</li> <li>using relative clauses beginning with who, where, which, when, whose, that or with an implied (i.e. omitted) relative pronoun</li> <li>learning the grammar for Years 5 and 6 in <a href="#">English Appendix 2</a></li> </ul> </li> <li>indicate grammatical and other features by:
